BALLET CALIENTE TERMS OF RENTAL AGREEMENT

- Ballet Caliente (Venue) will provide use of the facility for your specified party package, and will provide a 'ballerina hostess' to lead dance related activities.
- Venue will provide tables and chairs to accommodate food and gifts.
- Birthday party hosts are responsible for cake, serving utensils, food, beverages, paper products and decorations.
- At least ONE adult must remain with the party group at all times.
- There will be NO running or horseplay in the rental space, to include the dressing room, restroom or parking lot.
- NO street shoes are allowed in the dance studio.
- NO smoking, drugs or alcohol are allowed on property.
- Venue is not responsible for lost or stolen items.
- Ballet Caliente (Venue) requires a **\$50 deposit** to hold your party date and time. The **remaining balance is due in full the day of the party**. Payment may be made by cash or check, we do not accept credit card payment.
- All Party Packages are priced for an 8 guest minimum. Parties fewer than 8 guests are required to pay the full amount. Parties exceeding the 8 guest minimum will be charged an additional \$5/guest.
- Parties going over the agreed upon contracted time (to include 15 minutes of setup & cleanup) **will be charged \$25 per additional 15 minutes**.
- **All cancellations must notify the Venue one week prior to the party date to receive a full refund of your \$50 deposit.**
- **Cancellations less than 48 hours prior to the party date will be charged the full rental amount.**

Party hosts are responsible for their guests per the above mentioned terms of agreement, and the attached release of liability. Host are REQUIRED to remain with children until they are picked up by their parent/guardian.
